BDOC relayed caller stated he spotted a drone hovering over Bldg. 791, but was unable to give a description at the time. I, (b)(7)(C) spotted one drone over the previously mentioned location and another drone in the area of on-base Officer housing heading toward (b)(7)(C) entry control point. From approximately 1840 until 2330, myself and other patrols spotted approximately 5-10 drones across mainly the south, southeast, and southwest directions of the installation. BDOC contacted YPSO and Hampton PD to assist with tracking drones in residential areas off-base, but contact was not made with any potential drone operators. At approximately 2130 hours, while at Bldg. 330, (b)(7)(C) and myself witnessed a drone traveling from the northeast side of the installation to the southwest side of the installation with red and white flashing lights. After traveling approximately 100 yards in the same direction, the drone turned around and headed back toward the northeastern side of base crossing over the west and east ramps of the flightline. The drones varied in size ranging up to 3' x 3' in size with a combination of red, white, and/or green blinking lights. However, the drones were not close enough to get an actual visual on their size, weight, and distinguishing marks. The drones appeared to be flying to and from the Gosnold's Hope Park area just south of the installation. I initiated an IVA down Nealy Ave when (b)(7)(C) reported a drone sighting at (b)(7)(C). I confirmed his sighting and relayed its direction of travel was heading towards the Flight Line. (b)(7)(C) confirmed the drone had made it over the Flight Line and relayed it was hovering above Bldg 775 (b)(7)(C). I began conducting an IVA for additional drone sightings, when I spotted approximately nine (09) drones in a staggered formation traveling adjacent ward rd heading towards the fuel barge pier. At approximately 1930, I was instructed by (b)(7)(C) / (b)(7)(C) to (b)(7)(C). I went back to Ward Rd to see if I could sight any additional drones but had negative findings. (b)(7)(C) reported a swarm of drones over King St Bridge and requested assistance, I responded and when I arrived on scene I spotted nine (09) drones in diamond formation flying over (b)(7)(C) heading towards the Flight Line. (b)(7)(C) and I followed the swarm onto the flight line where we lost visual of the swarm over the bay. On 07 December 2023 at approximately 1830 hours I (b)(7)(C) responded to drone sighting on JBLE (Joint Base Langley-Eustis). I traveled down Flightline Road to building 763 where the report of a drone sighting was called in. After not spotting the drone at this location I moved down Flightline Road to building 790 where I spotted 2 drones flying in a circle over the east ramp of JBLE. Sitting and observing the drones moved towards the South Branch Back River where I lost sight of them. Approximately 5 minutes later I spotted another drone moving from Northeast of JBLE toward the West Ramp of JBLE flying directly across the runway. At approximately 2030 hours I spotted 3 drones flying directly over building 775 on JBLE in opposite directions. 3 hours later at approximately 2330 hours I spotted 3 more drones flying east from above JBLE's airfield across the South Branch Back River where 2 appeared to have landed across the river. 2 more drones then traveled North from the location that the 2 drones landed across the South Branch Back River. There were approximately 6 to 8 different drones flying on or in proximity to JBLE. The high probed area seemed to be the JBLE airfield as several drones hovered over or near the parking ramps. On 6 December 2023, at 1845 hrs (b)(7)(C) contacted BDOC to report a possible drone sighting over the Shellbank Fitness Center traveling towards (b)(7)(C) and near the NASA (b)(7)(C) BDOC directed all posts and patrols to initiate sector sweeps. Throughout the duration of the incident, there were an estimated 15-20 drones over Langley AFB and Bethel Manor. The drones were approximately 3' x 3', with four rotors, and had cameras. They consistently stayed around 1500'-2000' in the air. They primarily focused on the following locations: (b)(7)(C) the Bay near Ward Rd, The Marina, (b)(7)(C) Housing, and (b)(7)(C) The drones were consistently egressing south towards King Street in Hampton and Northeast towards Poquoson. The response lasted until 2330 hrs. At 0020 hrs and 0120 hrs, patrols conducted sector sweeps and initiated LP/OPs with negative findings. At 0125 hrs, Security Forces terminated their response.
